CRITERIA AND TERMS AND CONDITIONS

These terms apply to both scholarships. Please initial and date each page and sign the declaration on the final page.

Eligibility criteria

The applicant must:

- be enrolled and studying accountancy (either full or part time) at a Chartered Accountants ANZ accredited tertiary institution offering Chartered Accountant, Associate Chartered Accountant or Accounting Technician qualifications
- complete the application form in full, following all instructions and providing all required documentation
- satisfy the criteria specified in the personal impact statement section of the scholarship application form
- be able to demonstrate that he/she intends to pursue accounting as a career
- be registered with youunlimitedanz.com
- be available to attend an interview to discuss their application
- Disclose any conviction and if required give consent for a criminal record search. Non-disclosure could make an applicant ineligible.

Background information and acknowledgements

- 1. Chartered Accountants ANZ and its appointed scholarship Selection Panel (the Committee) will evaluate each application based on the quality of the information provided by the applicant and his/her referees. In addition to evaluating the quality of the application material, the Committee will also consider extra curricular activities, community involvement and career ambitions.
- **2.** Decisions made by Chartered Accountants ANZ and/or the Committee will be final and no correspondence or discussion will be entered into.
- **3.** By submitting the application, the applicant acknowledges that Chartered Accountants ANZ and the Committee will be collecting personal information about him/her and that Chartered Accountants ANZ will rely on such information for the purposes of determining the outcome of the application.
- **4.** By signing the declaration on the application form the applicant confirms that the information provided is true and correct. A false or misleading declaration made by an Chartered Accountants ANZ member will constitute a breach of Chartered Accountants Australia and New Zealand's Code of Ethics.
- **5.** The applicant acknowledges that Chartered Accountants ANZ is not obligated to award any scholarships in any year and scholarships will not normally be granted to applicants receiving a full salary.
- **6.** The applicant authorises Chartered Accountants ANZ and/or the Committee to lawfully obtain at any time from any person or entity, any information about the applicant that Chartered Accountants ANZ and/or the Committee considers necessary or desirable in order to process the application and the applicant authorises such person or entity to release this information.
- 7. Scholarship Recipients may apply in subsequent years for further funding from Chartered Accountants Australia and New Zealand.
- 8. Unsuccessful applicants may also re-apply in subsequent years.

- **9.** The Scholarship may be held concurrently with other awards or scholarships obtained by the applicant. However, applicants must include in their application details of any other funding of any nature applied for or already awarded to the applicant. If funds have already been received, applicants should include details of how those funds were applied.
- 10. Two written references are required on behalf of the Applicant one of whom must be an academic referee who should highlight the skills of the applicant as a student and his/her ability to complete the accounting qualification on schedule. The referee should also outline the applicant's intention to enter the New Zealand accounting profession, and his/her level of support for the application. The second referee must be a character referee who knows the applicant personally who should outline not only the applicants' ability as a student, but also his/her contribution to, and support of his/her iwi/hapū/whanau or community through extra curricular activities.

General Terms and Conditions

- 1. Applicants who are awarded a scholarship (Recipient) must sign this document confirming that he/she agrees to the Terms and Conditions under which the scholarship has been awarded and must provide a copy to Chartered Accountants ANZ before any scholarship funds will be paid. The Recipient must acknowledge to Chartered Accountants ANZ receipt of all scholarship funds.
- 2. Scholarship funds may only used by the Recipient to pay for tuition fees and study related costs. The scholarship funds must not be used for payment of professional membership fees or any other purpose not expressly authorised by Chartered Accountants ANZ.
- **3.** If the Recipient of either scholarship is currently in their final year of study, then only half of the Scholarship funds will be awarded and the second instalment will not be paid in the following year.
- **4.** If the Recipient is an Chartered Accountants Australia and New Zealand member, he/she will be bound by the Rules of the New Zealand Institute of Chartered Accountants (as amended from time to time) and by Chartered Accountants ANZ's Code of Ethics (as amended from time to time).
- **5.** The Recipient must acknowledge the funding received from Chartered Accountants ANZ in all published materials.
- 6. In the event the Recipient discontinues or withdraws from his/her course of study during a scholarship funding year, or the focus of the Recipient's study or research changes, the Recipient must immediately notify the Committee in writing, following which the Committee may:
 - **a.** terminate the Scholarship, in the event of which, Chartered Accountants ANZ will not be obliged to make any further payments to the Recipient; and/or
 - **a.** require the Recipient to refund all or part of the scholarship funds paid to, or on behalf of, the Recipient.
- 7. If the Committee considers that the Recipient is making insufficient or unsatisfactory progress in achieving his/her qualification, including the grades achieved, the Committee may:
 - **a.** terminate the Scholarship, in the event of which, Chartered Accountants ANZ will not be obliged to make any further payments to the Recipient; and/or
 - **b.** require the Recipient to refund all or part of the Scholarship funds paid to, or on behalf of, the Recipient.



- 8. If Chartered Accountants ANZ or the Committee becomes aware that any information provided to it by the Recipient is false, erroneous or misleading, Chartered Accountants ANZ, without limitation, reserves its right to:
 - **a.** terminate the Scholarship, in the event of which, Chartered Accountants ANZ will not be obliged to make any further payments to the Recipient; and/or
 - **c.** require the Recipient to refund all or part of the Scholarship funds paid to, or on behalf of, the Recipient.
- **9.** Chartered Accountants ANZ may review and amend the terms and conditions applying to the scholarships at any time.

Additional terms

Additional eligibility criteria, scholarship details, and terms and conditions specific to the scholarship for which application is being made are set out in the relevant appendix, which forms part of the Terms and Conditions of the Scholarship.

Additional eligibility criteria

The Applicant must be able to demonstrate he/she is of New Zealand Māori descent, by way of iwi and/or affiliation.

Additional Scholarship details

The full Ngā Raumanako Māori Scholarship value is \$5,000 paid in two instalments over two years.

The full Suzanne Spencer Memorial Māori Scholarship value is \$6,000 paid in two instalments over two years.

Applicants will be notified of the Committee's decision by Friday 28 September 2018 Decisions made by the Committee will be final. Correspondence or discussion concerning any aspect of the award of a scholarship will not be entered into. The successful applicant will be invited to the NKMoA conference on 26-27 October 2018 in Christchurch in order to accept the Scholarship.

Without limiting the composition of the Committee, the Committee shall include members of both Chartered Accountants ANZ and Ngā Kaitatau Māori o Aotearoa.

Additional Terms and Conditions

The Recipients must attend an awards ceremony held as part of the NKMoA Hui-a-Tau, where the awards will be presented by a Chartered Accountants ANZ and NKMoA representative. Hui-a-Tau attendance will be complementary for the Recipient.

The Recipients must provide one progress report to Chartered Accountants ANZ and NKMoA in each year of the Scholarship funding. The format for the report will be provided by Chartered Accountants ANZ. The report must include a detailed account of how the scholarship funds were spent and the academic achievement gained up to the date of the report.

The successful applicant of the Ngā Raumanako Māori Scholarship will be offered the opportunity of a summer internship for 2018/19 with one or two major accounting firms depending on the student preference and firm availability. Please note that a separate process for the internship will apply.
